



Bandon Crossings Annual Pass Agreement

Thank you for wanting to join our “family”

Please refer to the information sheet for pass descriptions and pricing.

When you buy an annual pass:

- You can buy an Annual Pass any time during the year, good for the next 365 days.
- You can buy an Annual Pass for 1 year. At the end of the year you can purchase another one.
- You will Receive 10% off all soft goods in Golf Shop while your annual pass is active
- Couples Pass is valid for 2 adults living in the same household.
- Annual pass holders may bring up to three guests who can play with them at Crossings Club rates.
- You can join the USGA to maintain a GHIN handicap for \$45 per year.
- You will be set up as a customer with full address information in the system.
- Tee times can (and should) be booked up to 7 days in advance, **preferably online**.
- If you purchase a combined green fee and cart plan, it is for a single seat in a shared cart
- If you don't choose a prepaid cart plan, then you will get reduced golf cart rental rates (18 holes \$15 per seat, 9 holes \$9 per seat)
- If you request to be a single rider it will be an additional \$8 on the day you play golf.

Our Commitment to you

- Bandon Crossings will do our very best to ensure you have a well-maintained golf course and cart in order to enjoy a great round of golf and camaraderie.
- There will be some days that you will not be able to play golf:
 - We are closed Christmas Day, and 2-3 days each spring and fall for course maintenance.
 - There may be days the course is hosting a tournament or other event and there will not be a time for regular play
 - We may have to close unexpectedly due to unforeseen eventualities, such as government closures, acts of vandalism or other physical problems, fire, severe weather where it may be unsafe to play, or other situations where we are not able to offer you a safe and playable situation.
- Your pass will end in 12 months, regardless of any lapses in play due to the above mentioned or any other act out of our control.
- No refunds will be issued due to time missed due to the above circumstances.
- If you are too sick to play golf for more than a month, then talk to us about placing a hold on your pass.

Your responsibilities:

- **Cart Usage:** You agree to proper use of golf carts in a safe manner that does not disturb the playing area and follow cart path rules set by staff based on conditions. No one under 16 may drive a cart. Improper use of the golf course or the carts may lead you to forfeit your Annual Pass, without refund. You may get a warning for less egregious actions.
- **Alcohol Usage:** You agree not to bring alcohol onto Bandon Crossings premises for consumption. The only alcohol to be consumed on site is alcohol purchased on site. No underage drinking is permitted. Since a violation concerning alcohol may jeopardize Bandon Crossings' license to sell and serve alcohol, a violation is grounds for the termination of your Annual Pass, without refund.
- **Damages:** You agree to be responsible for any damage to the golf course and property and accept the responsibility to repair or replace.
- You agree to follow the rules of **good sportsmanship**. Bandon Crossings reserves the right to expel any golfer who uses excessive foul language, illegal substances or exhibits aggressive or violent behavior.
- You agree to the financial commitments of the pass you select.
- You agree to do your best to enjoy your time at Bandon Crossings and make wonderful memories, and hopefully some nice shots.
