# Thank you for wanting to join our "family"

## Benefits you can enjoy with a Monthly Pass:

- Benefits you enjoy with a Monthly Pass:
- Receive 10% off all soft goods in Golf Shop
- Reserve up to 1 week in advance, preferably online
- Reduced golf cart rental rates
- You may bring up to three guests at Crossings Club rates.
- You can join the USGA to maintain a GHIN handicap for \$45 per year.

#### The details:

- You can join our family any time during the year.
- Minimum term is 12 months, then continue to keep you golfing as much as you want
- If you need to cancel after 12 months, just give us 30 days notice to make sure you are not billed again.
- Requires either bank debit established (ACH) or credit card on file to automatically process payments.
- Billing and payments will be processed on the day of the month when you sign up.
- Any necessary price increases will be announced December 1 and applied on January 1.
- You will be set up as a customer with full address information in the system.
- Tee times can (and should) be booked up to 7 days in advance, **preferably online**.
- If you purchase a combined green fee and cart plan, it is for a single seat in a shared cart.
- If you request to be a single rider it will be an additional \$9 on the day you play golf.
- The monthly rate is guaranteed until January 1. If any price increases are necessary, they will be announced before December 1.

## Our Commitment to you

- Bandon Crossings will do our very best to ensure you have a well-maintained golf course and cart in order to enjoy a great round of golf and camaraderie.
- There will be some days that you will not be able to play golf:
  - We are closed Christmas Day, and 2-3 days each spring and fall for course maintenance.
  - o There may be days the course is hosting a tournament or other event and there will not be a time for regular play.
  - We may have to close unexpectedly due to unforeseen eventualities, such as government closures, acts of vandalism or other physical problems, fire, severe

weather where it may be unsafe to play, or other situations where we are not able to offer you a safe and playable situation.

- No refunds will be issued due to time missed due to the above circumstances.
- If you are too sick to play golf for more than a month, then talk to us about placing a hold on your pass.

## Your responsibilities:

- Cart Usage: You agree to proper use of golf carts in a safe manner that does not
  disturb the playing area and follow cart path rules set by staff based on conditions.
  No one under 16 may drive a cart. Improper use of the golf course or the carts may
  lead you to forfeit your Annual Pass, without refund. You may get a warning for less
  egregious actions.
- Alcohol Usage: You agree not to bring alcohol onto Bandon Crossings premises for consumption. The only alcohol to be consumed on site is alcohol purchased on site. No underage drinking is permitted. Since a violation concerning alcohol may jeopardize Bandon Crossings' license to sell and serve alcohol, a violation is grounds for the termination of your Annual Pass, without refund.
- **Damages:** You agree to be responsible for any damage to the golf course and property and accept the responsibility to repair or replace.
- You agree to follow the rules of **good sportsmanship**. Bandon Crossings reserves the right to expel any golfer who uses excessive foul language, illegal substances or exhibits aggressive or violent behavior.
- You agree to the financial commitments of the pass you select.
- You agree to do your best to enjoy your time at Bandon Crossings and make wonderful memories, and hopefully some nice shots.
